

# LANDSCAPE/HORTICULTURE TECHNICIAN/VTC VSC UP PAT Bargaining Unit

Grade 12 Exempt

#### BASIC FUNCTION

To provide landscape design, installation and maintenance, including greenhouse stock during the spring and fall and to advise and assist with the college academic/horticulture programs. Plan, manage and maintain operations of the orchard; maintain expertise in field. Manage and oversee Vermont Tech Community garden.

### CHARACTERISTIC DUTIES AND RESPONSIBILITIES

- To plan and maintain a wide variety of landscaping projects for college grounds and the Veteran's Cemetery, including: layout and design, plant production, assess and perform pruning, fertilization, removal and replacement, watering, mulching and protection.
- Oversee and supervise scheduled and ongoing maintenance of lawns, perennial beds, annual plantings, trees and shrubs, including: main campus, veterans' cemetery, farmstead and greenhouse operations.
- Manage greenhouse operations, including: plant production, maintain materials inventory, maintain plant life, eradicate pests and manage greenhouses.
- Assist horticulture faculty with a variety of teaching duties, including: conduct and supervise labs, explain and demonstrate techniques, consult with students as needed. Provide workshops for visitors.
- Provide functional supervision to college grounds staff and a large number of student workers, including: assign projects, demonstrate and oversee work methods and schedule assignments.
- Maintain landscape/horticulture/orchard supplies, including: research and order materials, sort and store materials and tools, follow and inform other workers of safety requirements with chemicals, tools, etc.
- Assist/carryout design and testing of new materials, equipment, lab projects. Consult regularly with faculty to plan and evaluate specific lab activities and methods to evaluate student performance.
- Work with the Director of Physical Plant to coordinate and support ongoing maintenance and projects related to college grounds.
- Stay abreast of new and changing technology in the horticulture field.
- Plan, manage and maintain the operations of the Vermont Technical College orchard including: orchard maintenance, budget, materials inventory

maintenance, advertising, public and community relations, and staffing scheduling.

- Maintain expertise in field as related to orchard operations: sales, advertising, chemicals, pruning, layout and design.
- Oversight, management and supervision of the Vermont Technical College Community Garden including: planting, growing, harvesting of crops; garden maintenance and end of season clean-up; community relations; budgeting; advertising and working with vendors.

Perform related duties as assigned.

#### SUPERVISION RECEIVED

Minimal supervision is received from the Director of Physical Plant. Direction is received from the Academic Dean or other senior staff or faculty.

#### SUPERVISION EXERCISED

Functional supervision of several student workers.

## MINIMUM QUALIFICATIONS

Associates or bachelors degree in an appropriate discipline, plus one or two years of relevant technical experience, or a combination of education and experience from which comparable knowledge and skills are acquired.

- Strong academic background in horticulture and related fields.
- Extensive experience in grounds maintenance and landscape design.
- Good basic administrative and supervisory skills.
- Good teaching and advising skills
- Ability to deal effectively with a wide range of college personnel and individuals outside the institution.
