## Minutes of the VSC Board of Trustees Executive Committee meeting Tuesday, May 22, 2018 APPROVED

The Vermont State Colleges Board of Trustees Executive Committee conducted a Committee meeting on Tuesday, May 22, 2018 at the VTC Campus, room 203 in Williston, Vermont.

Chair Hindes called the meeting to order at 3:03 p.m.

1. <u>Quick review of the charge and responsibilities of the Executive Committee (link/PDF to be sent in advance).</u>

The Committee reviewed the charge and responsibilities of the Executive Committee as outlined in the VSCS Board of Trustees Handbook. Trustee Luneau provided background on the evolution of the Committee charge and responsibilities.

At 3:12pm, Trustee Dickinson moved the Executive Committee of the VSC Board of Trustees enter executive session, pursuant to 1 V.S.A. § 313(a)(3) to discuss the employment and evaluation of a public officer. Trustee Luneau seconded the motion. The Committee made it clear that any decision to reappoint any such public officer would take place in an open meeting. The motion was duly adopted.

Along with the members of the Board present at this meeting, in its discretion, the Board invites the Chancellor, to attend.

The Committee returned from executive session at 4:25pm. Chair Hindes moved to accept the Chancellor's self-assessment and his priorities for the forthcoming year and recommended that he be reappointed through June 30, 2019 and that his compensation be increased on July 1, 2018 by \$2600. Trustee Milne seconded the motion. The motion passed unanimously.

Chair Hindes moved the committee accepts and endorses the Chancellor's recommendation to reappoint of each of the Presidents for a 2 year term with the understanding that a more formal performance

review will take place in September 2018 and that the presidents receive and increase in their compensation of \$2600 for FY2019. Trustee Milne seconded the motion. The motion passed unanimously.
