Trustee Hindes stated the primary purpose of the meeting was to solidify the Committee's starting points for the search—process, timeframe, preferences and next steps.

The committee agreed:

- We are a special board committee; trustees opted to not use the executive committee
 - Three imperatives for the search
 - Move expeditiously
 - Keep board members informed
 - o Listen to internal and external stakeholders
- Internal candidates are welcomed (defined as current VSCS employees and trustees)
- Summary process for the search
 - 1. Over next 2 weeks, seek to identify candidate(s) through proactive outreach.
 - 2. If no candidates are identified, consider hiring a specialty search firm.
 - 3. Vet external and internal candidates (including collecting stakeholder input).
 - 4. Bring finalist(s) to trustees for consideration and decision.
- Calendar for the search
 - Target decision date is late June, early July
 - General preferences for "top of mind", first choice candidate:
 - o Well qualified Vermonter, who understands Vermont
 - Working familiarity with VSC or ability to develop it quickly
 - Open minded, no preconceived solutions to current challenges
 - Open minded, no bias for or against particular VSC member institutions
 - Should be
 - Effective leader
 - Transition leader
 - Change facilitator
 - Experience with redesigning and rebuilding
 - Experienced and able to make difficult decisions
 - Experienced and able to manage criticism, push back
 - <u>politically and Politically sensitive</u>
 - o Interest in the opportunity and commitment through summer 2021

- Commit to a credible search practice and to comply with applicable rules
- Allow successful candidate to select the new CFO and any external consultant

- Solicit recommendations for persons to be contacted re interest in position
- Finalize basic elements for the search
 - Position description and preferred qualifications
 - Restructuring year assignment description
 - Case statement ("Why this is an attractive opportunity")
 - o Compensation

- Define internal stakeholders and how to engage them
 - Presidents, faculty, staff, students, CO leaders, others?
- Define external stakeholders and how to engage them
