1. Chair Pieciak called the meeting to order at 10:53 a.m.

Chair Pieciak announced that Trustee Tester would be joining the Long Range Planning Committee.

2. Approval of the July 23, 2020 minutes

# Trustee Grinold moved and Trustee Giambatista seconded the motion to approve the meeting minutes from July 23, 2020. The motion was approved unanimously.

3. <u>Discussion of Chancellor's Recommendations for Strategic Action in 2020-2021</u>

Chancellor Zdatny reminded the Committee of the Strategic Priorities adopted by the Board at the October 16, 2020 meeting. Based on those priorities, the Chancellor, in consultation with the Council of Presidents, is recommending that the VSCS focus on developing strategic initiatives and identifying key performance indicators for the current academic year. These are described in detail in the meeting materials starting on page 7 here.

Trustee Lippert moved and Trustee Luneau seconded the motion to recommend to the Board the acceptance of the Chancellor's Recommendations for Strategic Action in 2020-2021. The motion was approved unanimously.

4. <u>Update on work of the Select Committee on the Future of Public Higher Education in Vermont</u>

Chancellor Zdatny provided information on the Select Committee. This Committee was created "to assist the State of Vermont in addressing the urgent needs of the Vermont State Colleges and develop and integrated vision and plan for a high-quality, affordable, and workforce-connected future for public higher education in the State." The Select Committee is comprised of 15 members from diverse backgrounds. The Steering Group, a subset of the Select Committee, is comprised of five people. President Joyce Judy serves as Chair of both the Steering Group and Select Committee. The Steering Group selected NCHEMS, an external consulting firm, to assist the work of the Select Committee by analyzing the issues, challenges and opportunities facing VSCS, as well as to draft a formal action plan to drive change and innovation in the VSC System. The first interim report of the Select Committee is due on December 4, 2020, the second report on February 12, 2021 and the final report on April 16, 2021.

#### 5. Discussion of Timelines

Chancellor Zdatny presented various timelines, including the key dates for Legislative Select Committee meetings and reports, the legislative process for the state budget, the VSCS Board's meeting calendar, development of the system budget, an overview of ongoing System transformation work, and estimated timelines for obtaining approval of any substantive changes by NECHE (accreditor) and the Department of Education The timeline presentation can be found starting on page 77 of the meeting materials.
