2. Discussion of Fall Plans 2020

Chancellor Sophie Zdatny invited the Presidents to each share their currents plans for reopening in Fall 2020.

Community College of Vermont President Joyce Judy shared that CCV is providing several options for their students to access over 700 courses this fall; synchronous, hybrid, online, or flex classes.

Castleton University Interim President Jonathan Spiro shared that CU will teach courses will be online in the fall, other than a handful of exceptions, such as Nursing Clinicals. The residence halls will be open. Student can live on campus after signing the Spartan Pledge. Most of the on-campus services and amenities will be open.

Northern Vermont University President Elaine Collins shared that NVU will provide face to face, hybrid and online instruction. NVU will provide single occupancy rooms for residential students.

Vermont Technical College President Pat Moulton shared that VTC's Fall 2020 plan includes a hybrid model of instruction, with a combination of remote and face-to-face delivery, in a low residency model.
