1. Call to Order

Chair Jefferson called the meeting to order at 11:16 a.m.

2. Public Comment

There was no public comment.

- 3. Approval of Meeting Minutes
 - a. March 7, 2022
 - b. May 9, 2022

Trustee Moran moved and Trustee Durfee seconded the motion to approve the minutes from the March 7, 2022 meeting The motion was approved with two abstentions by Trustee Lippert and Trustee Ragouzis.

Trustee Moran moved and Trustee Lippert seconded the motion to approve the minutes from the May 9, 2022 meeting. The motion was approved with one abstention by Trustee Ragouzis.

4. Announcement/Introduction of Chief Diversity Officer

Chair Jefferson introduced Dr. Jae Basiliere as the inaugural Chief Diversity Officer of Vermont State University. Chair Jefferson shared that this is a permanent position that reports to the president and has been a priority hire to meet Vermont State University's mission, vision, and commitment to diversity, equity, and inclusion.

5. Update on hiring and DEI for Vermont State University

Chief Human Resource Officer Sarah Potter presented an update on the hiring for Vermont State University and the incorporation of DEI into those practices. That presentation can be found here. Chair Jefferson asked for a check back in a year with data related to the efficacy of these practices.

6. Update from VSC DEI Transformation Work Group

Dr. Basiliere provided an update from the DEI Transformation Work Group on its progress since the Committee's May meeting. The group have continued to use the three pillars of data informed decision making to inform teams as they go through their design process. Dr. Basiliere shared two examples of their ongoing work including working directly with registrars to look at structures through the DEI lens and identifying those that might have been unintentionally set up to work against students in the past, and working with a cross-functional team to ensure that the collection of identity-based data is used and treated with current best practices. Kathleen Mason, Coordinator for Diversity, Equity and Inclusion at Vermont Technical College, shared that a pilot program has been started to support incoming nursing students who are late admits or nonnative English speakers, Vermont Tech is continuing to support student athletes who are often underrepresented minorities and they also have a program supporting TRIO students (first generation and low-income students). Mary Brodsky, Executive Director of Human Resources, Diversity, Equity, and Inclusion at Community College of Vermont shared that CCV is excited to continue to collaborate with Dr. Basiliere and CHRO Potter. CCV is hoping to establish an Affinity space for people of color, leveraging resources to provide safe spaces for BIPOC students, faculty, staff, and their allies. Mary Brodsky also provided an update on recent DEI activities held at CCV, including a community-wide discussion and small group self-moderated discussions of the book "The Sum of Us" by Heather McGhee. She also discussed a recent training through the Racial Equity Institute.

7. Update on proposed anti-racism pledge from Student Diversity and Inclusion Task Force

Dr. Basiliere gave an update on behalf of the students, sharing that conversations have started about what the work will look like once the pledge is finalized. What is emerging is a desire to find a balance between wanting to be advocates for their community while also building and expanding the community for students who need the opportunity to connect with others. Trustee Ragouzis shared that he will be meeting with the VSCA later in August regarding student life and DEI. He also plans to visit each of the individual campuses to explore common areas of interest, as well as each campus' unique interests. Dr. Basiliere explained that the digital work to launch the pledge has been completed and the students involved in the pledge are refining their plans for its launch.

8. <u>Discuss committee name change to Diversity, Equity, Inclusion and Social Justice</u> (DEISJ)

Chair Jefferson opened the discussion for the potential name change of the committee, stating that this change would reflect and align with the ongoing transformation work. Trustee Dickinson asked for the definition of Social Justice as it applies to this committee. Dr. Basiliere replied that it relates to the idea that there is a mandate in higher education to provide equitable access to education for all students. The language of social justice emphasizes the fact that it must be "active." Chair Jefferson asked if the committee would like to table this question until the next meeting and Trustee Ragouzis replied that he would like to bring this topic to the students for their input. It was agreed this topic would be held over until the next meeting for additional information and discussion.

9. Other Business

There was no other business.

Chair Jefferson adjourned the meeting at 12:23 p.m.
