# Minutes of the VSCS Board of Trustees Ad Hoc Search Committee meeting held Thursday, August 17, 2023, at 8:30 a.m. via Zoom - UNAPPROVED

1. Chair Dickinson called the meeting to order at 8:30 a.m.	

2. Public Comment

3. Approval of August 3, 2023 Minutes

### <u>Trustee Zeller moved and Trustee Durfee seconded the motion to approve the minutes of</u> <u>August 3, 2023. The motion was approved unanimously.</u>

4. <u>Motion/vote on revised "Qualifications and Competencies" for Interim Presidency</u> position

#### 5. Update from Search Firm

Chancellor Zdatny shared that, at the request of the committee, she had reached out to the search firm and received three resumes, which have been shared with the trustees. Next steps are first round interviews and in preparation for that, the determination of a set of questions to share with the candidates beforehand. Chancellor Zdatny also reminded the committee about the online Unconscious Bias training sent to all trustees.

## 7. Executive Session

At 8:54 a.m. Trustee Durfee moved that the Committee enter executive session pursuant to 1 V.S.A. § 313(a)(3) to discuss the employment of a public officer.
