## Minutes of the VSCS Board of Trustees Meeting held Monday, January 22, 2024, at 1:00 p.m. via Zoom – UNAPPROVED

1. Vice Chair Cluver called the meeting to order at 1:06 p.m.

#### 2. Public Comment

Mary Collins offered a comment voicing concern about the possible censoring of a comment she made on the VTSU social media pages.

Mary Droege shared her frustration with how Administrative Optimization 2.0 decisions were handled.

Chair Dickinson thanked the commenters and reminded anyone who had further thoughts to share to please email them.

3. Approval of November 13, 2023, November 17, 2023, November 29, 2023 Minutes

Trustee Zeller moved and Trustee Bloomer seconded the motion to approve the November 13, 2023, November 17, 2023, November 29, 2023 meeting minutes. The motion was approved with two abstentions.

4. Report from the Finance & Facilities Committee

Trustee Silverman shared information on the Claire Fisher Heist and Mae Niles Scott Nursing Scholarship Endowment, including that preference, per the trust, shall be given to those students who plan to pursue a nursing career in the Northeast Kingdom. Further information can be found <u>here</u> on pages 18-20.

Trustee Silverman moved and Trustee Luneau seconded the motion to approve the Claire Fisher Heist and Mae Niles Scott Nursing Scholarship Endowment. The motion was approved unanimously.

Trustee Silverman referenced VTSU's proposed rates for Tuition, Fees, Room, and Board for academic year 2024-2025. He noted the proposal increases tuition and fees by 3.5%, eliminates the separate orientation fee, and eliminates lab fees attached to specific courses. The comprehensive fee and tuition have been adjusted to reflect these changes.

Trustee Silverman moved and Trustee Jefferson seconded the motion to approve Resolution 2023-015: 2024-2025 VTSU Tuition, Fees, Room & Board. The motion was approved unanimously.

Trustee Silverman shared information about the new fee for one-to-one devices (technology) for those students who lack a device. The fee, estimated at \$1,258, split over two semesters in the student's first year with the university, assures that each student has access to the necessary technology to be successful in a hybrid university. Students with documented financial hardship will be eligible to receive a loaner device.

<u>Trustee Silverman moved and Trustee Zeller seconded the motion to approve Resolution</u> <u>2023-016: 2024-2025 One-to-One Device (Technology) Fee. The motion was approved unanimously.</u>

Trustee Silverman reviewed proposed revisions to policy 403-A, which reduces the strategic initiative reserve from 4% to 2% of the total available general fund appropriation, gives direct control to the Board to use unspent strategic initiatives funds from the prior fiscal year for another purpose, and caps an institution's annual proportional change in appropriation to no more than 1% per year. Details can be found here on pages 26-28.

# <u>Trustee Silverman moved and Trustee Zeller seconded the motion to approve revised</u> <u>Policy 403-A: Allocation of State General and Capital Fund Appropriation. The motion</u> was approved unanimously.

Trustee Silverman concluded by sharing other matters covered at the December 11 committee meeting including (1) a review of the first pass of the FY24 shared services and chancellor's office budgets, (2) an update on the Vermont State University Master Plan, (3) an update on the ERP assessment update, and (4) a brief review of first quarter results.

#### 5. Report from the Diversity, Equity, and Inclusion Committee

Trustee Jefferson provided a report from the January 8th meeting of the DEI committee. The committee welcomed the new VTSU Chief Diversity Officer, Dr. Oyibo Afoaku; they heard an educational presentation from Mary Brodsky, CCV's Dean of People and Culture, entitled "Calling-In vs. Calling-Out" based on the works of Loretta Ross; and Trustee Perry Ragouzis introduced the anticipated formation of a VSC Student Association Diversity and Equity Committee which is expected during Spring 2024.

#### 6. Report from the Education, Personnel and Student Life Committee

Trustee Cluver provided an overview of the January 8th meeting of the EPSL committee which included a CCV-VTSU Transfer Pathways progress update; an update on Vermont State Center for Agriculture and Food Entrepreneurship (CAFÉ); an update on VSC Student Association Constitution revision; an update on VTSU student government, and a brief presentation on AI and pedagogy at CCV and VTSU. VTSU Provost Atkins then provided a summary of the addendum to the new academic program proposal in Restorative Justice, details of which can be found <a href="https://example.com/here-provided-new-academic-program-proposal-pr

# Trustee Jefferson moved and Trustee Flint seconded the motion to approve the proposal for a new academic program in Restorative Justice. The motion was approved unanimously.

Trustee Ragouzis shared updates underway at the VSC Student Government Association as it condenses from representing five institutions to two institutions. The group will be sharing a schedule of the VSCSA's meeting times with the Board.

#### 7. Report from the Audit & Risk Management Committee

Trustee Zeller reviewed the recommendation from the January 15<sup>th</sup> meeting of Audit and Risk Management Committee to hire Withum as the independent auditors for the Vermont State Colleges for Fiscal years 2024 through 2027. A thorough, open, request for proposal process was conducted that resulted in four highly qualified auditing firms. After evaluation of organization structure, audit approach, firm qualifications, and price, it was recommended to

rehire Withum for this work. To maintain independence and integrity in this service, Withum will be changing audit partners from Kieth Goldie to Zach Laflash.

Trustee Zeller moved and Trustee Tester seconded the motion to approve Withum as the Independent Auditors for 2024-2027. The motion was approved unanimously.

#### 8. Approval of revisions to Board of Trustees Handbook

General Counsel Patty Turley reviewed the proposed updates to the Board of Trustees Handbook which can be found <u>here</u> on pages 66-76. These changes include updated language reflecting the shift from five institutions to two institutions, as well as updated links.

## <u>Trustee Zeller moved and Trustee Durfee seconded the motion to approve the revisions to the Board of Trustees Handbook.</u> The motion was approved unanimously.

#### 9. Report from the Presidents

CCV President Joyce Judy shared that today is the first day of spring semester and noted a 3% increase in enrollment from last spring with nearly five thousand students enrolled in 650 classes across the state. Additionally, CCV is running 119 courses in high schools and tech centers – an increase from 92 last spring. President Judy then shared that Katie Mobely, Dean of Enrollment for CCV, Maurice Ouimet, VP of Admissions & Enrollment for VTSU, and Jay Jacobs, UVM's VP of Enrollment, testified before House Senate and House Education committees, coming together for the first time to speak about higher education in Vermont. Finally, President Judy shared that CCV is about to move into new quarters in the St. Johnsbury Fairbanks Museum's new annex. The ribbon cutting will be on February 15<sup>th</sup> and all are invited. Trustee Luneau requested a report from CCV at the next Board meeting regarding the number of high schools participating in dual enrollment and how many high school and tech centers there are in Vermont that are working in cooperation with CCV.

VTSU President David Bergh reported that Administrative Optimization plans are being implemented this semester and Academic Optimization 2.0 has also been finalized and is being implemented and targeted for work over the coming months in preparation for a full Board review in April. Additionally, VTSU is working on a list of institution events and opportunities for trustee engagement at the campuses which should be out shortly.

#### 10. Government Affairs Update

Drake Turner, Director of Governmental and External Affairs, gave a brief report on the first four weeks of the Legislative session. The Chancellor has spent time in the State House over the past two weeks meeting legislators and introducing herself to some key committees. She has also been introduced to the Lieutenant Governor, President Pro Tem of the Senate, and Speaker of the House. Introductory testimony was also provided to the Senate Education and Senate Institutions committees. Upcoming, introductory testimony will be provided to the House Education committee, and the House Appropriations committee in early February. More

testimony to key committees is expected to be scheduled in the coming weeks. The Governor's budget address will be coming in the next day.

#### 11. Report from the Chancellor

Chancellor Beth Mauch shared some background about herself and her extensive experience in higher education. One of her passions in higher education is removing barriers (academic, social/emotional and financial) for students who might not otherwise attend college. Chancellor Mauch expressed her enthusiasm to be working with the VSC on their goal of transforming to ensure access to high quality education for all Vermonters. She closed by mentioning how impressed she is with the support the VSC receives from the Vermont Legislature and looks forward to working with them.

### 12. Report from the Executive Committee

Chair Dickinson shared that the Executive Committee met on January 16<sup>th</sup> for an introductory meeting with new Chancellor and concentrated on outlining goals and priorities for the coming year.

#### 13. Nominating Committee appointments

Chair Dickinson described the current slate of Nominating Committee members and asked if other Trustees wanted to serve on the Nominating Committee. Hearing none, Chair Dickinson called for a motion to reappoint the current slate of members to the Nominating Committee.

Trustee Jefferson moved and Trustee Luneau seconded the motion to reappoint Trustee Bombardier, Trustee Dickinson and Trustee Lippert to the Nominating Committee. The motion was approved unanimously.

#### 14. Additional Business

Trustee Silverman requested a follow-up on the possible censorship issue raisedduring the public comment section of this meeting. President Bergh agreed there would be follow-up.

Chair Dickinson adjourned the meeting at 2:26 p.m.



It is with great pleasure that I put forward a request to fund an endowment in the name of Sophie Zdatny, former Chancellor of the Vermont State Colleges. Sophie served as Chancellor of the VSC from 2020 to 2023 leading through a time of tremendous turmoil and change. With its very existence as the higher education backbone of Vermont on the line, throughout her tenure Sophie was a stalwart champion of the system's students, faculty, and staff. She worked tirelessly to forge a sustainable path forward that preserved the critical access and affordability mission of VSCS for our students, in service to our state.

To do this required her to lead the system through unparalleled but unavoidable change with compassion and resolve. Throughout the process, Sophie stayed true to her belief in the value of public higher education and the importance of keeping students at the center of the work, challenging others to build an educational experience that serves their needs now and more importantly into the future.

To honor this commitment, the Board of Trustees, colleagues, partners, and friends have created a scholarship in her name. As designed, this scholarship is a direct testament to Sophie's commitment to Vermont, Vermonters and the value of a public higher education. To that end, this scholarship will promote and support students taking advantage of transfer pathways between Community College of Vermont and Vermont State University.

Eligible students will receive a scholarship in their last term at CCV and in their first year at VTSU. The goal is to support student affordability and accessibility taking advantage of the high value transfer pathways between our two colleges.

The initial funding value of this scholarship is \$35,809.72. Pledge donations in the amount of \$11,040.28 are anticipated over the next three years. Additional donations will be sought to expand this valuable scholarship in the coming months. I am therefore requesting that this scholarship be endowed by the Board of Trustees.

Dr. Atkins,

It is with great enthusiasm that I write this letter to nominate Dr. Anne Slonaker as VTSU's 2024-2025 Faculty Fellow. Dr. Slonaker's work in literacy impacts our teacher education program and Vermont policy initiatives. Dr. Slonaker's research encompasses over 20 years of dedication and a recent year-long sabbatical in which she researched literacy practices across the state of Vermont.

Dr. Slonaker's work greatly informs our Education program. Anne teaches literacy courses that span undergraduate early childhood, elementary, and secondary education as well as graduate courses. Even before she engaged in her sabbatical work, Anne's courses on "Disciplinary Literacy" and the "Ill Structured Problem" were well received at National Conferences in English and Special Education. Her knowledge of literacy allows her to develop strong relationships with the community to create meaningful placement opportunities. Recently, Anne and I completed a semester long literacy project with Mettawee Community School (MCS). At MCS, Anne connected with the principal and teachers. Anne utilized her sabbatical research to recognize strong practices while assisting the school in re-thinking the role of curricular changes. Her commitment to the learning needs of pre-service teachers should be commended. In the midst of literacy controversy, Dr. Slonaker presents students with all sides of the debate ensuring that they are prepared to walk into any school, using any curricular program, and teach in a way that reaches all students and centers social justice.

Dr. Slonaker's research also influences the daily strategies that practicing teachers implement and informs Graduate work and thesis projects. As a professor in the graduate program, Anne has guided theses on various literacy related topics like: Kalb's work, "Exploring the Relationship between Oral Fluency, Intrinsic Motivation to Read, and Reading Self-Efficacy for Adolescents in Intervention" and Richer's "The Exploration into Culturally Responsive Pedagogy in Vermont." In Introduction to Educational Research Anne served as a guest lecturer providing guidance on educational research, literacy practices, and qualitative methods. She encourages students to think beyond their current understanding of research and reach into their passions. This, Anne describes through her discourse analysis of a lend a book listsery of Phish participants in the mid 2000s!

Connecting her musical passion to her work is evidence of the ways in which literacy and research are pervasive influences in her life. It is this commitment to the field of literacy that brought me to nominate her as a Faculty Fellow. Anne has been committed to the field of literacy since her undergraduate work. Since then, she pursued a PhD in Curriculum and Instruction with a concentration in Literacy. And, most recently Anne completed a meta-analysis of literacy practice to guide her listening tour of Vermont educators. The current controversy surrounding literacy practices has left educators and administrators fumbling through curricular packages and choosing one side or the other in the great "Reading Wars." However, Anne transcends the reductive arguments currently plaguing our understanding of literacy by diving deeply into the work and exploring that which our teachers know and understand. She provides students, Education Department faculty, and indeed, anyone interested in listening an understanding of literacy that goes beyond the Science of Reading.

Dr. Anne Slonaker's depth of literacy knowledge reaches beyond theoretical undertakings in preservice to the daily practices and interventions in schools. From VTSU to the Statehouse to National service concerning policy work, Anne is a fierce advocate for all Vermont students. For example, she presented twice to the House Education Committee on Vermont's literacy practices and serves as a Policy Analyst for the state of Vermont through the National Council of Teacher's English.

Dr. Atkins, I thank you for your consideration of Dr. Anne Slonaker as Faculty Fellow for the 2024-2025 school year. Anne's commitment and passion to literacy education are an example of that which a Faculty Fellow should embody. Literacy research is her life! Anne is an integral member of our department, our community, and the field of literacy research.

#### **Assessment Report Highlights – Current State**

- Challenges
  - Ellucian Colleague is not built to support a system with multiple institutions
    - Complications with cross-enrollment calendar, financial aid, billing, shared curriculum
  - Exceptional challenges exist with HR/payroll and the use of UKG
  - General challenges with integration of products (Slate, UKG, and others), reporting, and customization
- Timing Considerations
  - UKG is not viable long-term
  - Modern ERP systems are cloud-based



## **Assessment Report Highlights – Market Analysis**

- Suggested we consider ERP options with:
  - Robust functionality specific to higher education
  - Multi-institution capabilities
  - High scalability
- Provided an analysis of specific ERP products based on capability factors
- Presented optional paths forward
- Total cost of ownership estimates were provided



#### Steering Committee and Stakeholder Recommendation

- Move forward with ERP replacement, beginning with action steps related to readiness:
  - Architecture Assessment processes, user experience, requirements
  - Preliminary Resource Plan
  - Governance Structure
  - Project Timeline
- Upon completion of those four initial steps, move to budget modeling and Request for Proposal (RFP) development



## **Recommendation Assumptions**

- Current ERP does not meet institutional needs
- Seek a product that will accommodate multiple institutions in one instance to maximize efficiencies
- New solution will offer streamlined and integrated user experience for students and employees
- New system will foster a culture of continuous improvement
- We will be intentional about correcting inaccurate information in current systems before implementing a new product



#### **Recommendation Guardrails**

- A single, shared instance of an ERP must provide functionality to support the distinctive functional needs of multiple institutions
- A new ERP must support seamless integration across functional areas, including HR, finance, and the Student Information System
- A new ERP must support seamless integration between other VSC systems that support business needs, including external vendors
- Budgeting and preliminary resource planning must be completed in preplanning phase before moving forward with RFP



#### **Recommendation Risks**

- Resource capacity of existing staff with subject matter expertise required to implement a new ERP solution
- Change fatigue in recognition of the significant pace of transformation on all of the impacted areas
- Risk of replicating existing data issues in new ERP system
- Readiness for this change is at varying levels across functional areas and institutions
- Current system sustainability in a time of rapid market change

- Clearly documented objectives, goals "why" clearly documented
- Architecture Assessment (process, user stories, requirements)
- Resource Plan
- Governance Structure
- Change Planning
- Project timeline
