VERMONT STATE COLLEGES SYSTEM OVERVIEW

The VSCS is currently undergoing a significant transformation, with the guidance of the Governor, Legislature, the Board of Trustees, and the State's Select Committee on the Future of Public Higher Education in Vermont. The VSCS began working on internal transformation in summer 2020 with the VSCS Forward Task Force and several institutional tasks forces including NVU Strong and VTC's Transformation Advisory Team.

The <u>Vermont State Colleges System</u> (VSCS) is comprised of two member institutions – <u>Community College of Vermont</u> (CCV) and Vermont State University (VTSU). The system educates over ten thousand Vermonters and non-Vermonters each year, employs over three thousand Vermonters, and in Spring 2020, graduated over eighteen hundred Vermonters and outof-state students into the workforce with certificates and degrees.¹

SCOPE OF SERVICES

The Vermont State Colleges System seeks interested parties to submit competitive bids to lease the five-acre You-Pick Apple Orchard in Randolph Center, VT.

The initial lease duration will be one year, ideally beginning Spring 2024. With agreement, subsequent lease terms shall be extended up to a three-year duration, with appropriate opt-out clauses.

EVALUATION

Responses will be evaluated on experience, capabilities, alignment of mission and core values, and costs. Priority will be given to a proposal that shows an:

- 1. Ability to maintain the orchard to a professional standard, using integrated pest management practices (IPM) and other best-practices in the care of the trees, the production of healthy quality fruit, and the sustainability of the orchard environment.
- 2. Willingness to provide VTSU access to Orchard operations to serve as an educational learning space/resource, and for coordinated functions with VTSU departments, programs and alumni, including:
 - a. Being the entry location for an annual campus cross-country race
 - b. Sales of apples to external organizations/partners
 - c. Access to the orchard for alumni day events
 - d. Sale of VTSU-Randolph maple syrup at the farm shed during u-pick season
 - e. VTSU student, faculty and staff discounts on apples
- 3. Willingness and qualification to provide instruction (e.g., lead tours, serve as a guest lecturer or provide support in areas of orchard management (e.g., pest management, production systems, pruning, marketing);
- 4. Openness to taking on VTSU student interns, and;
- 5. Retaining a community function to the orchard, including education and exposure of the public to a quality orchard experience, collaborations with local foodbanks for donations, outreach with schools, etc.

Method of Award

The proposals will be reviewed and scored by the Center for Ag and Food Entrepreneurship team and sent to leadership for final approval based on the submission requirements utilizing the scoring rubric attached. The VSCS, in its best interests, reserves the right to accept or reject any or all proposals, to accept or reject any item or combination of items therein, to waive any irregularities or informalities in any proposal or items therein, and/or to negotiate with particular bidders following the evaluation of proposals without right of recourse by other bidders. A top proposal would be assessed in the judgment of VSCS as best complying with all considerations set forth in this RFP. When VSCS has tentatively selected a successful proposal, VSC may engage in discussions with the bidder to formulate plans in greater detail, to clarify unclear items for either party, and to otherwise complete negotiations prior to formal selection.

GENERAL CONDITIONS

- 1. This RFP does not commit the Vermont State Colleges System to award a contract.
- 2. This RFP and the process it describes are proprietary to the VSCS and are for the sole and exclusive benefit of the corporation. No other party, including any Applicant, is granted any rights hereunder. Any response, including written documents and verbal communication, by any Applicant to this RFP, shall become the property of the VSCS and may be subject to public disclosure as described in the Confidentiality section, below.
- 3. Submission of a bid indicates acceptance by the party of the conditions contained in this RFP, unless clearly and specifically noted in the proposal submitted and confirmed in the contract between Vermont State Colleges System and the chosen party selected.
- 4. Responses shall be binding upon the chosen party and irrevocable for up to 60 days following the close of applications.
- 5. From the release date of this request for proposal until award of the contract, no contact with Vermont State Colleges System personnel or board members related to this solicitation is permitted. Direct all communications to the designated contact on the first page of this request.
- 6. The Vermont State Colleges System reserves the right to:
 - a. Request clarification and additional information from any party during the evaluation process.
 - b. Re-advertise with either an identical or a revised scope of work or cancel requirements in their entirety.
 - c. Issue subsequent RFPs based on refinement of concepts proposed in response to this request.
 - d. Conduct investigations of the qualifications of the Applicant as deemed appropriate.
 - e. Request the Applicant modify the submitted proposal to more fully meet the needs of the Vermont State Colleges System.

7.The VTSU Orchard shall be returned at the end of the lease in the same condition it was acquired in. (IE Pest management/ Number of spraying applications, or freshly pruned)

CONFIDENTIALITY

The Vermont State Colleges System complies with the Vermont Public Records Act, 1 VSA § 315 *et seq.* which requires public agencies to allow any person to inspect or copy any public record upon request. ORCHARD INFORMATION

There are roughly 4.5 acres, with 400 apple trees, historically managed by farm staff. Most apples are sold you-pick, to third parties, or donated to foodbanks. All of the trees were pruned by a hired professional. Trees are a combination of standard/semi-dwarf trees, mostly Macintosh and Cortland, some Empire, Macoun, Northern spy, and Liberty.

The orchard has been maintained conventionally. Pest management applications occurred up through 2023 with an older John Bean Airblast Sprayer, and seasonal mowing with a Kuhn Flail Mower. Water is available via 2 hydrants in the orchard.

The orchard includes a retail apple shed (no power or water), a small tin shed used for pesticide storage and mixing, and a small wooden shed for storage. There is a designated parking area. The retail operation includes a stockpile of wagons and apple pickers to aid customers in picking fruit. The University manages a webpage and call number to direct and inform customers.
