

- 1. <u>Call to order</u>: Chair Jefferson called the meeting to order at 1:01 p.m. Chancellor Beth Mauch introduced a new member to her team, Kayla Dewey, Executive Assistant to the Chancellor and Board of Trustees. Chair Jefferson introduced and welcomed new student trustee, Jason Musal as a member of this Committee. Chair Jefferson then asked VTSU President to share a brief update on DEI work at the University. He affirmed VTSU's commitment to continuously advancing DEI efforts. Structural and reporting line changes are in review, and VTSU is currently recruiting for open DEI positions. VP Beckwith will provide further details later in the meeting.
- 2. <u>Public Comment</u>. There was no public comment.

#### 3. Approval of Minutes – March 11, 2024

### <u>Trustee Musal moved and Trustee Bloomer seconded the motion to approve the March 11, 2024 minutes.</u> The motion was approved unanimously.

#### 4. CCV Progress Report on Three Pillars of DEISJ

Mary Brodsky, Dean of People and Culture at Community College of Vermont (CCV) provided a progress report on CCV's DEI initiatives. Guided by established guiding pillars, values, and priorities, CCV has been growing employee cultural competency through training and education using data informed practices in decision making. Some key events and initiatives included measuring employee attitudes by including DEI-oriented questions in the biannual staff survey which had an 85% response rate.

CCV has hosted or participated in a number of events, which celebrate diverse cultures including Winooski's Pride Festival, CCV's International Food Festival, CCV's World Music Day, and UVM's Annual Inclusive Excellence Symposium. A virtual BIPOC student affinity group open to CCV and VTSU was created, and group leaders plan to adjust their approach for next year to encourage more participation.

CCV has secured funding and is currently recruiting a Coordinator of Multicultural Teaching and Learning.

#### 5. VTSU Progress Report on Three Pillars of DEISJ

Kelley Beckwith, Vice President of Student Success at VTSU provided a summary of VTSU's DEISJ initiatives and recent progress. She started by recognizing Aurora Hurd and Oyibo Afoaku for their work advancing several initiatives in DEISJ this past semester. Both staff members have departed VTSU. VTSU is recruiting for two roles: Chief Diversity Officer and Assistant Director of DEISJ.

VTSU hosted a number of events to build community and belonging across the university including Harambee and Social Hour. These events were well attended thanks to support from the Student Government Association chapters, athletic programs, as well as individual faculty, staff and students. The DEISJ Advisory Committee was formed and was charged with developing strategic goals that align with the VTSU Strategic Plan. Other projects include implementation of a Campus Climate Survey, maintenance of a resource website, and communications of significant dates, holidays, and updates. DEISJ partnered with other departments to plan a two-day training event in October with a DEISJ expert.
