

1. Call to Order

Chair Jefferson called the meeting to order at 1:03 p.m.

2. Comments from the Public

There was no public comment.

3. Approval of December 9, 2024 Meeting Minutes

Trustee Flint moved and Trustee Musal seconded the motion to approve the December 9, 2024 minutes. The motion was approved unanimously.

4. Education Presentation

Chair Jefferson turned the meeting over to Associate General Counsel Kathryn Santiago. Attorney Santiago introduced the presentation topic: "The Impact of Federal Executive Orders on Higher Education" and Rodney Smolla, President of Vermont Law and Graduate School.

President Smolla focused his presentation on the Trump Administration's interpretation of what is and is not illegal discrimination, the attack on DEI programing, and the attempt to end or revise federal grants including grants that higher education institutions receive. He provided an overview of the SFFA v. Harvard decision by the U.S. Supreme Court, which prohibits institutions from using race as a factor in the admissions process. He then described the recent Dear Colleague Letter and FAQs, which extend the SFFA interpretation to other areas such as scholarships, grants, student groups, and academics. President Smolla used a four-pronged ladder approach to describe the likelihood of the Administration's success in its interpretations, applying Constitutional law. Of particular concern for higher education institutions is the probability of the Administration conditioning the acceptance of federal financing based on specific activities. Trustees asked questions regarding preparatory steps to address these efforts, the avenues for enforcement by the federal agencies, and the news that the Department of Education may be abolished.

Trustee Jefferson expressed her deep appreciation to President Smolla for his illuminating presentation.
